प्रधान मुख्य वन संरक्षक (कैम्पा) सतपुड़ा भवन मध्यप्रदेश भोपाल का पत्र क्रमांक/ए.पी.ओ./2020-21/454/1711 भोपाल दिनांक 20.11.2020 के अनुसार जिला-अनूपपुर अंतर्गत स्थानीय निकाय (जनपद पंचायत/जिला पंचायत/नगर निगम/नगर पालिका) नगरपालिका अनूपपुर क्षेत्र की लोक जैवविविधता पंजी का निर्माण किया जाना है। मध्यप्रदेश प्रतिकरात्मक वन रोपण निधि प्रबंधन और योजना प्राधिकरण (राज्य प्राधिकरण) कैम्पा मद अंतर्गत वनमण्डल को प्राप्त 25 प्रतिशत बजट राशि मुक्त की गई है।

इस परिप्रेक्ष्य में संस्था (महाविद्यालय/विद्यालय) शासकीय तुलसी महाविद्यालय अनूपपुर जिला अनूपपुर (म०प्र०) द्वारा लोक जैवविविधता पंजी निर्माण हेतु वनमण्डल को लोक जैवविविधता पंजी निर्माण हेतु राशि रुपये 1.00 लाख का परियोजना प्रस्ताव प्रेषित किया है। वन मण्डलाधिकारी के वित्तीय अधिकारों का उपयोग करते हुये वर्ष 2020-21 अंतर्गत संस्था शासकीय तुलसी महाविद्यालय अनूपपुर जिला अनूपपुर (म०प्र०) को कुल राशि रु. 1.00 लाख (शब्दों में एक लाख रुपये मात्र) वित्तीय स्वीकृति प्रदान की जाती है। इस स्वीकृति के क्रम में संस्था शासकीय तुलसी महाविद्यालय अनूपपुर जिला अनूपपुर (म०प्र०) को स्थानीय निकाय (जनपद पंचायत/जिला पंचायत/नगर निगम/नगर पालिका) नगरपालिका अनूपपुर क्षेत्र की लोक जैवविविधता पंजी का निर्माण हेतु स्वीकृत राशि की 37.5 प्रतिशत राशि प्रथम किस्त रु. 37500/- (शब्दों में सैंतीस हजार पाँच सौ मात्र) के भुगतान की स्वीकृति प्रदान की जाती है।

लोक जैवविविधता पंजी निर्माण का प्रगति प्रतिवेदन एवं प्रथम किस्त की राशि का उपयोगिता प्रमाण पत्र वनमण्डल को उपलब्ध कराये जाने पर संस्था को आगामी किस्त की राशि जारी की जायेगी। लोक जैवविविधता पंजी का निर्माण कार्य की अधिकतम अवधि एक वर्ष होगी। तथा इस हेतु स्वीकृत राशि एवं समय-सीमा में वृद्धि नहीं की जायेगी। राशि व्यय न होने पर शेष राशि संस्था द्वारा वनमण्डल को वापस किया जायेगा।
