  - h) to jointly participated in Campus Placement.
2. Government Tulsi College and Sanskar Law Colleges Anuppur agree to help identify and invite faculty members from the other institution to participate in research or development programmes
  3. Government Tulsi College and Sanskar Law Colleges Anuppur agree to encourage collaboration between faculty and scientists from the two institutions. Specifically, institutions will encourage members of their faculties to undertake short visits to, or take up fixed-term visiting assignments at, each other's institution as per the existing norms. Terms and conditions for each visit or an assignment, including those concerning stipend, travel, and housing, name of the concerned faculty member will be worked out between Government Tulsi College and Sanskar Law Colleges Anuppur
  4. Exchange students/faculties will be selected by mutual agreement between the home institution and the host institution.
  5. An exchange faculties/student will continue to be treated as full-time at his/her home institution.
  6. An exchange faculties/student will be considered as full-time "exchange" faculties/student at the host institution.
  7. The host institution will evaluate an exchange faculty's/student's performance in each course or module, award an experience letter/grade or marks, and issue a letter to that effect.



9. Government Tulsi College and Sanskar Law Colleges Anuppur will exchange information on research and educational programmes and teaching/learning material and other literature relevant to their educational and research programmes.
10. Government Tulsi College and Sanskar Law Colleges Anuppur agree to explore ways to share teaching/learning material, and other relevant literature, while respecting each other's intellectual property and other rights.
11. Government Tulsi College and Sanskar Law Colleges Anuppur agree to help identify and invite faculty members from the other institution to participate in conferences, workshops and short-term courses.
12. Government Tulsi College and Sanskar Law Colleges Anuppur agree to respect each other's rights to intellectual property. Further, the intellectual property rights that arise as a result of any collaborative research or activity under this MoU will be worked out on a case-by-case basis, and will be consistent with the officially laid down IPR policies of the two institutions.
13. This MoU will take effect from the date it is signed by representatives of the two institutions. It will remain valid for **five years**, and may be continued thereafter after suitable review and agreement. Either institution may terminate the MoU by giving written notice to the other institution six months in advance. Once terminated, neither Government Tulsi College and Sanskar Law Colleges Anuppur will be responsible for any losses, financial or otherwise, which the other institutions may suffer. However Government Tulsi College and Sanskar Law Colleges Anuppur will ensure that all activities in progress are allowed to complete successfully.
14. Should there be a dispute relating to any aspect of academic cooperation, Principal, Government Tulsi College, Anuppur and Chairman, Sanskar Law Colleges Anuppur will jointly resolve the dispute in a spirit of independence, mutual respect, and shared responsibility.

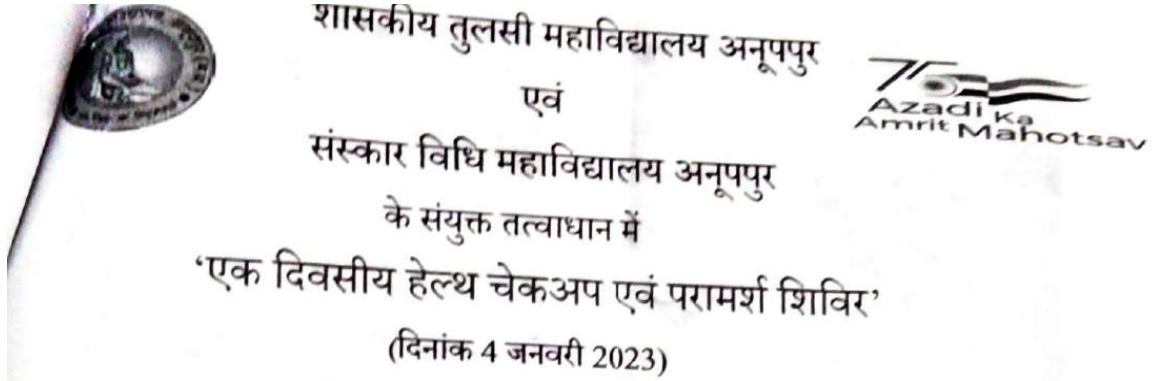

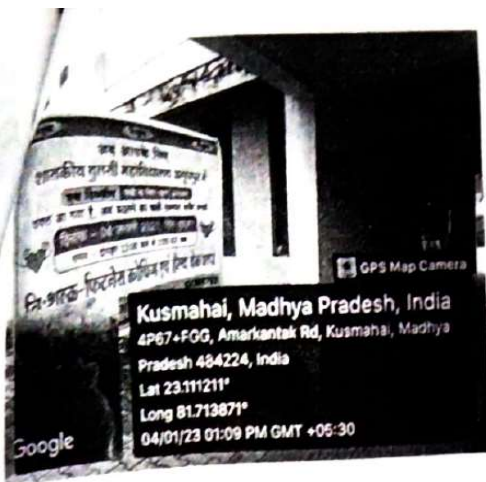
